

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.happydancecreditrepair.com, and Happy Dance Credit Repair, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Happy Dance Credit Repair, LLC include www.happydancecreditrepair.com and Happy Dance Credit Repair. The Happy Dance Credit Repair website is a Credit Repair & Counseling site. By using the Happy Dance Credit Repair website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Happy Dance Credit Repair may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Happy Dance Credit Repair's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Happy Dance Credit Repair collects and uses your personal information to operate and deliver the services you have requested.

Happy Dance Credit Repair may also use your personally identifiable information to inform you of other products or services available from Happy Dance Credit Repair and its affiliates.

Sharing Information with Third Parties

Happy Dance Credit Repair does not sell, rent or lease its customer lists to third parties.

Happy Dance Credit Repair may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique

personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Happy Dance Credit Repair. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Happy Dance Credit Repair website.

Use of Cookies

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
